- A. Secretary's Report:

  - 2. Sent Mr. Russell from Berry Road another citation for garbage.
- D. Police Report- Chief LaRue
  - 1. 75 calls including 2 burglaries, 1 assault, 3 theft, 2 domestics, 1 criminal mischief, 4 accidents And 1 overdose.
  - 2. Officer Carlton and Officer Balsamo got certified in DUI testing.
- E. Fire Dept. Report Shaun Felton
  - 1. 26 incidents. 5 motor vehicle accidents, 6 fire, 5 medical and 10 misc.
  - 2. 1 Monthly meeting, 2 in house training. Billy Boy Pizza and Dugas family donated 1955 American Lefrance engine to the Fire Dept. This was one of the original engines of the dept.
