Reorganization meeting. Read advertisement for reorganization and regular meeting for January. Reorganization meeting was adjourned at 6:14 pm.

*December 2019. 176 calls. 4 criminal arrests – 3 DUI, 1 domestic assault, 4 traffic citations, 5 non-traffic citations.

*4th qtr 2019 report. 595 calls, 17 criminal arrests – 9 DUI, 3 assaults, 5 misc. arrests, 62 traffic citations, 12 non traffic Citations.

*We had 2,171 calls in 2019, more than we've ever had. I am asking the board to consider promoting our part time Officer, Joe Chirumbolo to a full time officer for our department. He is an asset to our department. We lost one of our part time officers recently, as he took a full time position elsewhere. Hiring Joe to full time will help lessen the overtime hours. He is covered under his parent's health plan, so we won't have to pay his health insurance for another 3 years. Tim motions to hire Joe Chirumbolo as a full time officer effective January 7, 2020.
